AFTER-SCHOOL PROGRAMS ARE FUNDED THROUGH PRIVATE DONATIONS AND SMALL GRANTS. THE PROGRAM PROVIDES ENRICHMENT PROGRAMMING FROM 3:30-5:30 THAT INCLUDES HEALTHY HABITS, STEM ACTIVITIES, ARTS AND CRAFTS, AND SCOUT PROGRAMS. THE PROGRAM IS FREE OF CHARGE AND OPEN TO ANY STUDENT; PREFERENCE IS GIVEN TO CHILDREN FROM LOW-INCOME HOUSEHOLDS WITH THE GREATEST ACADEMIC NEED.

THE CHESAPEAKE MULTICULTURAL RESOURCE CENTER SCHOLARSHIP FUND IS DESIGNED TO IDENTIFY AND ASSIST STUDENTS WITH THE MOST NEED.

ANYONE CAN ACCESS THE CENTER FOR GENERAL ASSISTANCE, HELP WITH TRANSLATIONS, COMPLETING DOCUMENTS, AND REFERRALS TO SERVICE PROVIDERS. 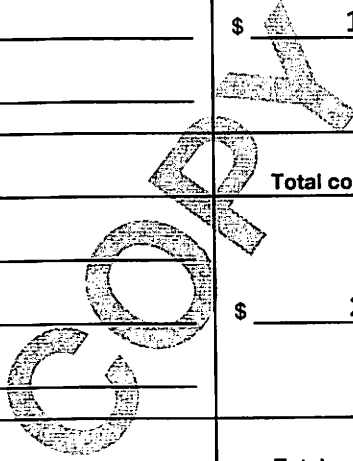

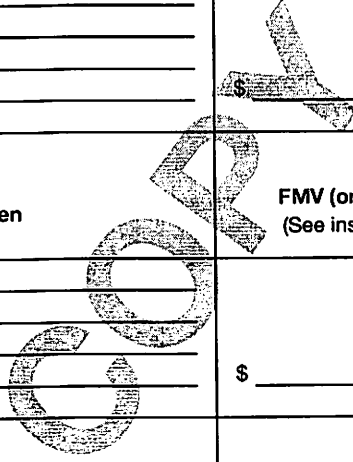
